Location license checklist

THE NINE STEPS

- ☐ **1. Gather your documents** **COMMON STALL**
Confirm Secretary of State good standing and no outstanding DOR tax liabilities (DOR: 404-417-4445) before you start.
- ☐ **2. Register at gacoam.com**
Create the account; confirm your email with the verification code.
- ☐ **3. Complete the online application**
Business info, every owner/officer, machine class B and count, ID uploads.
- ☐ **4. Pay online** **COMMON STALL**
ACH or credit card only. Payment can take up to 10 business days to clear — everything waits on it.
- ☐ **5. Open the trust account** (bank visit)
Titled exactly: *[your legal business name] — In Trust for The Georgia Lottery Corporation*.
- ☐ **6. Submit the EFT authorization form** (bank signature)
COMMON STALL
Fax 404-215-8897 or portal upload + email confirmation. No EFT form, no approval.
- ☐ **7. Compliance checks run**
Background, credit, DOR, SOS, lawful presence — every owner. Weak credit may mean a refundable \$2,500–\$7,500 deposit.
- ☐ **8. Pass the site inspection** **COMMON STALL**
Real ownership, operating business, and enough non-cash redemption merchandise on the shelves.
- ☐ **9. Approval and go-live**
Post the paper license, sign with your master license holder, machines connect within ~10 business days.

HAVE READY BEFORE YOU SIT DOWN

- FEIN and Georgia taxpayer ID (11 digits)
- Photo ID for every owner, officer, and shareholder
- SSNs for each owner (entered only at gacoam.com)
- Alcohol license / GA Lottery retailer numbers, if any
- Card or bank details for the online payment

FEES

\$125 per Class B machine, per year
\$100 processing & administrative fee (non-refundable)
Fees are not prorated. Expect ~4–6 weeks end to end.

KEY DATES

License year: **July 1 – June 30**
Renewal window: **May 1 – June 30**
From July 1: **\$1,000** statutory late fee
More than 90 days late = cannot renew.
